This third supplement (the "**Third Supplement**") is supplemental to, and should be read in conjunction with, the base prospectus dated 27 May 2025 (the "**Base Prospectus**"), the first supplement to the Base Prospectus dated 30 June 2025 (the "**First Supplement**") and the second supplement to the Base Prospectus dated 6 August 2025 (the "**Second Supplement**" and, together with the First Supplement, the "**Previous Supplements**"), in each case, in respect of Certificates issued under the Note, Warrant and Certificate Programme (the "**Programme**") of BNP Paribas Issuance B.V. ("**BNPP B.V.**"), BNP Paribas ("**BNPP**") and BNP Paribas Fortis Funding.

The Base Prospectus and the Previous Supplements constitute a base prospectus for the purposes of Article 8 of the Prospectus Regulation. "**Prospectus Regulation**" means Regulation (EU) 2017/1129 of 14 June 2017, as amended. The Base Prospectus received approval no. 25-186 on 27 May 2025, the First Supplement received approval no. 25-256 on 30 June 2025 and the Second Supplement received approval no. 25-335 on 6 August 2025 from the *Autorité des marchés financiers* (the "**AMF**"). Application has been made to the AMF for approval of this Third Supplement in its capacity as competent authority under the Prospectus Regulation.

BNPP (in respect of itself and BNPP B.V.) and BNPP B.V. (in respect of itself) accept responsibility for the information contained in this Third Supplement, save that BNPP B.V. accepts no responsibility for the information contained in the Third Amendment to the BNPP 2024 Universal Registration Document (in English) (as defined below) and the updated disclosure in respect of BNPP. To the best of the knowledge of BNPP and BNPP B.V. (who have taken all reasonable care to ensure that such is the case), the information contained herein is, subject as provided in the preceding sentence, in accordance with the facts and does not omit anything likely to affect the import of such information.

Unless the context otherwise requires, terms defined in the Base Prospectus, as amended by the Previous Supplements, shall have the same meanings when used in this Third Supplement.

To the extent that there is any inconsistency between (i) any statement in this Third Supplement and (ii) any statement in, or incorporated by reference in, the Base Prospectus, as amended by the Previous Supplements, the statement referred to in (i) above will prevail.

References in this Third Supplement to paragraphs of the Base Prospectus are to the Base Prospectus as amended by the Previous Supplements. References in this Third Supplement to page numbers in the Base Prospectus are to the page numbers in the Base Prospectus without taking into account any amendments made in the Previous Supplements.

This Third Supplement has been prepared for the purposes of:

- (A) incorporating by reference the third *Amendement au Document d'Enregistrement Universel 2024* in English dated 28 October 2025 (the "**Third Amendment to the BNPP 2024 Universal Registration Document (in English)**");
- (B) amending the "Recent Developments" section; and
- (C) amending the "General Information" section.

The incorporation by reference of the documents referred to in (A) above has been made to update the BNPP disclosure. The amendments referred to in (C) above have been made to reflect the updated BNPP disclosure referred to in (A) above. The amendments referred to in (B) above has been made to incorporate recent events in relation to the Issuer. The amendments referred to in (C) above have been made to update BNPP's corporate authorisation and share capital.

- (e) in the last paragraph on page 123 of the Base Prospectus, the second sentence is amended as follows:
- "Each of the documents incorporated by reference in (c) to (h) above will only be made available by the relevant Issuer or the Guarantor (if applicable) to which such document relates."

## RECENT DEVELOPMENTS

The "RECENT DEVELOPMENTS" section on pages 1630 to 1666 of the Base Prospectus (which was amended by virtue of the Previous Supplements) is completed with the following press release dated 30 October 2025 issued by BNP Paribas in relation to the 2025 SREP Notification:

"BNP Paribas has received the notification by the European Central Bank of the outcome of the 2025 Supervisory Review and Evaluation Process (SREP), which sets out the Group's capital requirements and leverage ratio on a consolidated basis.

The *Pillar 2 Requirement* (P2R) that the Group must meet as of 1<sup>st</sup> January 2026 on a consolidated basis is 1.73% (a decrease of 11 bps compared to 2024 SREP), including 1.05% in the form of *Common Equity Tier 1* (CET1) (down 9 bps compared to 2024 SREP).

As such, the CET1 requirement as of 1<sup>st</sup> January 2026 is 10.44% (excluding the *Pillar 2 Guidance*). It includes 1.50% for the G-SIB buffer, 2.50% for the Conservation buffer, 1.05% for the *Pillar 2 Requirement*<sup>1</sup> (P2R), 0.75% of countercyclical buffer<sup>2</sup> and 0.14% of systemic buffer<sup>2</sup>.

- The requirement for the Tier 1 Capital ratio is 12.23%<sup>3</sup> (of which 1.34% for the P2R).
- The requirement for the Total Capital ratio is 14.62%<sup>3</sup> (of which 1.73% for the P2R).
- The requirement for the leverage ratio remains unchanged at 3.85%<sup>3</sup>, including 0.10% of *Pillar 2 Requirement* (P2R-LR).

**As of 30 September 2025, the BNP Paribas Group is significantly above the regulatory requirements with:**

Additionally, the results of the 2025 stress test conducted by the EBA and the ECB have enabled the Group to be positioned in the first bucket of the ECB's Pillar 2 Guidance (P2G), within a range of 0 to 100 basis points, lower than the previous range of 50 to 200 basis points.

**These results reflect the structural improvements in the Group's profile, the solidity of its capital structure and the prudent management of its balance sheet."**

## AMENDMENTS TO THE GENERAL INFORMATION SECTION

The "**GENERAL INFORMATION**" section on pages 1667 to 1673 of the Base Prospectus is amended as follows:

- (a) the paragraph under the heading "1. Authorisation" on page 1667 of the Base Prospectus is deleted and replaced with the following:

"The establishment of the Programme was approved by resolutions of the Board of Directors of BNPP B.V. dated 8 May 2003. The update of the Programme and the issue of Securities under the Programme were approved by resolutions of the Board of Directors of BNPP B.V. dated 3 April 2025. No authorisation procedures are required of BNPP by French law for the update of the Programme or the giving of the Guarantees. The issue of Certificates issued by BNPP under the Programme is authorised pursuant to the Board resolution dated 19 December 2024, as completed by the resolution of the Board dated 10 October 2025."

- (b) the first paragraph under the heading "6. Legal and Arbitration Proceedings" on page 1668 of the Base Prospectus (which was amended by virtue of the Second Supplement) is deleted and replaced with the following:

"Save as disclosed on pages 294 and 295 of the BNPP 2024 Universal Registration Document (in English), pages 91 to 93 of the First Amendment to the BNPP 2024 Universal Registration Document (in English), pages 325 to 327 of the Second Amendment to the BNPP 2024 Universal Registration Document (in English) and pages 94 to 96 of the Third Amendment to the BNPP 2024 Universal Registration Document (in English), there have been no governmental, legal or arbitration proceedings (including any such proceedings which are pending or threatened of which BNPP is aware), during the period covering the twelve (12) months prior to the date of this Base Prospectus which may have, or have had in the recent past, significant effects on BNPP's and/or the Group's financial position or profitability.";

- (b) the first paragraph under the heading "7. Significant Change" on page 1668 of the Base Prospectus (which was amended by virtue of the Second Supplement) is deleted and replaced with the following:

"Except as disclosed in this Base Prospectus, there has been no significant change in the financial performance or position of BNPP or the Group since 30 September 2025 (being the end of the last financial period for which interim financial statements have been published).";
